ABOUT US

Our origins date back to 1655 when a group of clergy sons gathered for a service in St Paul's Cathedral and a collection was taken for the destitute families of priests dispossessed of their livings under Oliver Cromwell. The charity received a Royal Charter from Charles II in 1678. We have since grown by the amalgamation of various clergy support bodies and today we are the largest UK charity focused exclusively on supporting Anglican clergy families. We are widely known for our annual Festival Service which still takes place at St Paul's each year.

OUR MISSION

Our mission is to support serving and retired Anglican clergy families and their dependants in times of hardship. Our main way of doing this at present is to provide one-off grants to eligible households for whom the clergy stipend or other sources of income are, in particular situations, inadequate. In 2017, we widened our charitable objects to include the promotion of health alongside the prevention and relief of poverty or hardship and the relief of illness, whether physical or mental.




2017 INCOME INVESTMENT DONATIONS INCOME AND LEGACIES

MARK'S STORY

After years supporting his ordained wife and looking after four children, Mark found himself having to move out of the vicarage, due to the breakdown of his marriage. The diocese had found Mark a house to rent, but he required furniture to accommodate

his four children. Mark's priority was to create a stable home for his children while transitioning through his divorce. Mark was aware he could eventually apply for Housing Benefit and Council Tax Support, but had no savings and was also servicing two debts.

After applying to us for a hardship grant, Mark was awarded a gift of £5,000, which he was able to use towards furniture costs.

ANNE'S STORY

Anne had recently retired from ordained ministry, living in rented accommodation with little savings and a small church pension for income. Sadly, Anne's mother, who lived abroad, passed away suddenly. Anne was unable to afford the airfare to attend her mother's funeral. After applying to us, Anne was awarded a hardship grant of **£6,000**, which she put towards the cost of attending her mother's funeral. This helped relieve her financial worries during this difficult time.

WILLIAM'S STORY

William, a married vicar with three children, was struggling financially due to some recent unexpected expenses. The family had incurred several emergency costs including car repairs, vet bills and school trips. After applying to us, William was awarded a financial hardship grant of £5,300. This enabled him to respond to emergency bills and also allowed him to put some of the money aside towards a sabbatical and a much-needed family holiday.

- Serving and retired Anglican clergy and their dependants
- Divorced and separated spouses and civil partners of eligible clergy
- Widows, widowers and surviving civil partners of eligible clergy
- Anglican ordinands training for ministry in the UK

The relevant clergy must be working in or have worked in the UK, Ireland, the Diocese in Europe, the Isle of Man, or the Channel Islands, or be ordained mission partners working abroad under the sponsorship of a UK-based missionary society.

We are an independent and confidential organisation. Applications for financial hardship are subject to a financial assessment to ensure we are meeting our charitable object of 'relief and prevention of poverty or hardship'.All support is provided by our small team of grants officers.

A CLOSER LOOK AT CLERGY FINANCIAL WELLBEING

(Living Ministry survey, December 2017)

Sons & Friends co-funded with Ministry Division in 2017 some detailed analysis of the financial wellbeing of Anglican clergy and ordinands. Highlights of this and other research by Ministry Division included:

- Most clergy are doing well but 20% of ordained clergy and 34% of ordinands are struggling or 'just about getting by' financially
- 29% of ordained clergy with children under 16 in the household reported financial difficulties
- **43%** of those in stipendiary ministry said they were finding it difficult to save money regularly
- 17% of respondents (ordained clergy and ordinands) said they felt regularly, often or always burned out by their ministerial role
- 26% felt isolated in their ministry/training
- 20% felt isolated in their personal life

Sons & Friends exists to support these and others struggling in ordained Anglican ministry, so that they can flourish as they seek to serve God's people and their wider communities.
