ANNUAL ASSEMBLY - 12 NOVEMBER 2020

I am writing to confirm notice of our 2020 annual general meeting (now known under our revised Royal Charter as the Annual Assembly) which will take place via the Zoom video conferencing platform between **11.30am and 12.30pm on Thursday 12 November 2020**. A formal notice with agenda is enclosed.

We regret very much that we will not be able to meet in person at Guildhall, as had been our original plan. Given the COVID-19 pandemic and government restrictions, it was felt that the prudent option would be to hold the meeting virtually. The Court of Assistants (board of trustees) took this difficult decision after receiving advice from our lawyers BDB Pitmans. It follows that we will not this year be able to hold our usual pre-AGM Eucharist at St Mary-le-Bow Church or to host a lunch for Governors. We trust and pray that normal service will be resumed in 2021.

We hope however that you will still be able to join us online this year. The Annual Assembly will be a great opportunity to hear about the work of the charity, including formally receiving the Trustees' Report for 2019. Our Senior Treasurer, the Revd Canon Simon Butler, will provide a summary of the main points emerging from our Governor consultation earlier this year. There will be a chance to meet my successor as Chief Executive, Ben Cahill-Nicholls, whose brief profile is below. We are also delighted to propose to Governors three new members of the Court of Assistants and some new Governors.

Ben Cahill-Nicholls - new Chief Executive (from 26 October 2020)

Ben joins the charity from the Serco Institute and Foundation, where he has been Deputy Director. He began his career in the civil service and was an adviser to both the Laming Review and the House of Commons Education Committee. Subsequently, he held several senior posts in the education sector, including as Head of Policy & Communications at Newham College of Further Education, Senior Fellow at the Centre for Education & Employment Research, and Director of Community & Partnerships at Charterhouse School. In the 2015 general election Ben was a parliamentary candidate for the Liberal Democrats.



Ben is a trustee of the international development charity Mellon Educate UK and the youth charity RicNic, which he founded. He is also training for self-supporting ordained ministry in the Church of England, aiming to be a 'worker priest' continuing with secular employment alongside local ministry.
