The Governors are elected at the Annual General Court meeting and the qualification for election is the making of a donation to the charity of at least £100.

Anyone making the qualifying donation may request that his or her name be added to the list of those to be proposed for election as Governors at the next annual meeting. Once elected, a Governor remains a Governor for life without the necessity for further subscription – although further financial support is always welcome! The membership of the Court of Assistants, the trustees, is drawn from and elected by the Governors.
